Representative of Institute of Road Traffic Education presented their views before the Committee or the qualifications of Members and Chairperson of the Board, absence of systemized traffic enforcement in the country, lack of scientific investigation into road accidents and setting up of boards at state level.

7. Representatives of Automotive Research Association of India while welcoming the establishment of national safety board emphasized the need for coordinating various research institutes in road sector under the Board. They also expressed their apprehensions over the structure of the board and its members.

8. Dr. Sanjay Kulshreshtha presented his views on the reduction of deaths on roads and also on the alarming rise in number of vehicles in the country. He informed the Committee about the necessity for introduction of traffic safety subject at school level and redesigning of roads and yehicles for reduction of road fatalities.
